About FPSE

The Georgia Federation of Public Service Employees is committed to promoting and advocating for public employees, quality public services, efficiency in government and positive community engagement. The services our members provide too often go unnoticed, unappreciated and unrewarded. We fight to protect the interests of our members and the communities we serve.

Life Insurance - Our members automatically receive a \$20,000 life insurance benefit as part of their membership.

Disability Plan - Our members automatically receive a Long-Term Disability benefit plan as part of their membership. If a member is hurt on or off the job, and is unable to work, they will receive \$500 a month for up to (5) five years to assist them with their expenses.

Home Loan Program - As a member in good standing with the Georgia Federation of Public Service Employees (FPSE), you are eligible for participation in our “Making the Dream Come True” home loan program. *The program highlights include: No lender fees, no points, no application fees, no origination fees, discounted/competitive interest rate, \$3,000 toward closing costs, no appraisal fees (refunded at close of escrow up to \$600), purchase of home warranty plan (up to \$600), \$250 New home cash grant and much more!*

Educational Scholarships and Grants - Each year the FPSE Family Scholarship Programs provides financial support to our members, their children and grandchildren. Members attending an accredited college or university are eligible for scholarship assistance. Children and grandchildren of members who are graduating high school seniors may apply as well. This scholarship may be used for any field of study.

In addition to union provided insurance, our members may also elect to enroll in our discounted group voluntary accident, disability, life and critical illness plans.

FPSE Financial Services

FPSE members have free access to Certified Financial Planners and CPA on a wide variety of financial issues, including, but not limited to tax questions, retirement planning, estate planning, college savings, getting out of debt or loan problems.

FPSE Legal Support, Resources and Services

FPSE members have both phone and in-person access to qualified attorneys to assist them in a wide variety of legal issues. Areas of expertise include but are not limited to: Divorce and family law, Debt and bankruptcy, Landlord/tenant issues, Real estate transactions, Civil and criminal actions, and Contracts.

In addition to phone consultations, members are entitled to a free in person 30-minute consultation with a 25% reduction in customary legal fees thereafter.

FPSE Confidential Counseling

No-cost counseling service to help you address stress, relationship and other personal issues you and your family may face. It is staffed by highly trained master's and doctoral level clinicians who will listen to your concerns and quickly refer you to in-person counseling (up to 3 sessions per issue per year) and other resources for: Stress, anxiety, depression, job pressures, relationship/marital conflicts, grief and loss, problems with children and substance abuse.
